## Section 2: Eligibility Requirements

- **Tuition Policy:** Enrollment is conditional upon payment. Failure to meet the payment deadlines listed in Section 2 will result in the immediate revocation of the out-of-county transfer.
- **Athletic Eligibility:** Participation in interscholastic sports may be restricted per GHSA rules.
